



Official terms and conditions of the "FIRST MINUTE Summer 2026" promotion by

Join UP! Czech Republic s.r.o.

1. Introductory Provisions

1.1. These terms and conditions govern the "FIRST MINUTE Summer 2026" promotion (hereinafter referred to as the "promotion").

1.2. The organizer of the promotion is Join UP! Czech Republic s.r.o., with its registered office at Türkova 5b, 149 00 Prague 11, Company ID No.: 07752971, registered in the Commercial Register maintained by the Municipal Court in Prague.

1.3. The promotion is intended for customers of Join UP! Czech Republic, s.r.o.

1.4. The promotion applies to charter flights operated by Join UP! Czech Republic, s.r.o.

offered under the FIRST MINUTE Summer 2026 campaign with departures from Prague, Brno, Ostrava, and Katowice.

1.5. The promotion applies to all available lengths of stay.

2. Definition of the promotion

When purchasing a flight package as part of the FIRST MINUTE Summer 2026 campaign, the client will receive the following benefits:

a) Deposit:

- CZK 990 per person (for trips booked by January 31, 2026),
- 10% of the total price of the trip specified in the contract (for trips booked between February 1 and October 31, 2026).

The remaining portion of the price is payable 30 days prior to departure.

b) Flexible changes:

- Free change of date or hotel (at least 30 days prior to departure)
- Free name change (at least 7 days prior to departure)
- Free change of destination (at least 30 days prior to departure)

3. Duration of the promotion

3.1. Booking window: from January 1, 2026, to October 31, 2026.

Travel window: from May 1, 2026, to October 31, 2026.

3.2. The offer is only valid for bookings made during this period.

4. "Flexible changes" conditions

- 4.1. Only one change is permitted at least 30 days before departure (applies to the date, hotel, and destination).
- 4.2. The new trip must be in at least the same price range or in a higher price range. If the hotel is in a higher price range, the difference in price must be paid.
- 4.3. The client must verify the requested change of hotel or destination with the reservations department at email rezervace@joinup.cz, which will make the change. To make the change, it is necessary to report the original reservation number and the requested changes.
- 4.4. One name change is permitted at least 7 days before departure.

5. General provisions

- 5.1. CK Join UP! reserves the right to change or terminate the event without prior notice.
- 5.2. In the event of a dispute, the Czech version of these terms and conditions shall prevail.
- 5.3. The contract and these Terms and Conditions are governed by the laws of the Czech Republic.
- 5.4. In the event of a dispute, the parties shall attempt to reach an amicable solution; if this is not possible, the matter shall be decided by the competent court of the Czech Republic.
- 5.5. By participating in the promotion, each participant declares that they have read and agree to the content of these terms and conditions and their provisions.
- 5.6. The terms and conditions of the promotion come into effect on **January 1, 2026**.
