

Official terms and conditions of "FIRST MINUTE Winter 2025/2026" of Join UP! Czech Republic s.r.o.

1. Introductory provisions

1.1. These Terms and Conditions govern the terms and conditions of the FIRST MINUTE Winter 2025/2026 Event (the "Promotion").

1.2. The organizer of the event is Join UP! Czech Republic s.r.o., with registered office at Roztylská 1860/1, Prague 4, ID No.: 07752971, registered in the Commercial Register maintained by the Municipal Court in Prague.

1.3. The promotion is for Join UP! Czech Republic, s.r.o.

1.4. The promotion applies to charter flights of Join UP! Czech Republic, s.r.o.

offered under the FIRST MINUTE Winter 2025/2026 campaign with departures from Prague to Sharm El Sheikh (SSH) from 1.11.2025, Marsa Alam (RMF) from 1.11.2025 and Hurghada (HRG) from 2.11.2025, and departures from Katowice to Sri Lanka (LK) from 27.12.2025 and Zanzibar (ZNZ) from 27.10.2025.

1.5. The promotion applies to all available lengths of stay

2. Definition of Promotion

When purchasing a tour as part of the FIRST MINUTE Winter 2025/2026 campaign, the client will receive the following benefits:

- a) **Deposit:** 990 CZK per person, the rest of the price is payable 30 days before departure.
- b) **Flexible changes:**
 - Free change of dates or hotel (at least 30 days before departure)
 - Free name change (minimum 7 days before departure)
 - Free change of destination (minimum 30 days before departure)
- c) **Bonuses:**
 - Free trip for selected destinations

3. Duration of the event

3.1. The Promotion runs from 16 April 2025 to 31 August 2025.

3.2. The offer is only valid for bookings made during this period.

4. Conditions for "Flexible Changes"

4.1. Only 1 change is allowed at least 30 days before departure (applies to the date, hotel and destination).

4.2. The new tour must be at least in the same price range or a higher price range. If the hotel is in a higher price range, the difference in price must be paid.

4.3. The client must verify the requested change of hotel or destination with the reservations department at rezervace@joinup.cz, who will make the change. In order to make the change, the original booking number and the requested change must be reported.

4.4. Only 1 name change is allowed at least 7 days before departure.

5. Terms and conditions of the "Free Trip" bonus

6.1. The bonus applies to all currently available destinations within "FIRST MINUTE Winter 2025/2026":

PRAGUE → SHARM EL SHEIKH, MARSA ALAM, HURGHADA

KATOVICE → SRI LANKA, ZANZIBAR

6.2. The specific free trip and its date will be specified on the spot by the representative of the tour operator Join UP!

6.3. The trip must be booked with the local representative of CK Join UP!

6.4. The trip is available to all persons listed on the tour booking.

6. General provisions

6.1. CK Join UP! reserves the right to change or terminate the event without prior notice.

6.2. In case of disputes, the Czech version of these terms and conditions shall prevail.

6.3. By participating in the Promotion, each participant declares that he/she has read the contents of these Terms and Conditions and their provisions and that he/she agrees to them.

6.4. The terms and conditions of the Promotion shall come into force **on 16 April 2025**.
