



**Official Terms and Conditions of the
“500 CZK for Refreshments at Brno Airport” Promotion**

CK Join UP! Czech Republic s.r.o.

1. Definition of the Promotion

1.1. Every customer of CK Join UP! Czech Republic s.r.o. (hereinafter “CK Join UP!”) who has booked a trip departing from Brno-Tuřany Airport between June 15, 2026, and October 31, 2026, will receive a **500 CZK refreshment voucher**.

1.2. After picking it up at the Brno-Tuřany Airport Customer Service Center, the voucher can be redeemed at participating food and beverage outlets at the airport.

1.3. One (1) voucher is issued per travel contract concluded with Join Up! Travel Agency.

2. Terms of Participation

2.1. This promotion applies to Join Up! travel agency clients who are traveling under a valid travel contract and whose departure is from Brno-Tuřany Airport during the period specified in Section 1.1.

2.2. Information about the “500 CZK for refreshments at Brno Airport” promotion will be sent to the client along with their travel documents or hotel voucher prior to departure.

2.4. The client will pick up the voucher at the Brno-Tuřany Airport Customer Service Center.

2.5. When picking up the voucher at the Customer Center, the client must present a valid travel contract or contract number, either in printed or electronic form.

3. Promotion Dates

3.1. The promotion applies to departures taking place during the **period from June 15, 2026, through October 31, 2026, inclusive**.

3.2. Only clients with a departure during the period specified in Section 3.1 are eligible for the voucher.

4. Scope of the Offer

4.1. The voucher entitles the holder to receive refreshments worth 500 CZK at one of the partner establishments at Brno-Tuřany Airport.

4.2. The voucher can be redeemed at the following establishments:

- Starobrno Bar,
- Bageterie,
- Aviette Bar,
- Inflight Restaurant.

4.3. The voucher is intended for one-time use.

4.4. The voucher is non-transferable and may only be used by an eligible Join Up! travel agency client.

4.5. The voucher cannot be redeemed for cash or any other monetary consideration. The voucher cannot be exchanged for cash or any other form of payment.

4.6. The voucher must be redeemed in full and always at a single selected location.

4.7. If the purchase amount exceeds 500 CZK, the client is required to pay the difference between the purchase amount and the voucher value.

4.8. Any unused portion of the voucher's value will not be refunded or carried over to a future purchase.

4.9. The voucher may only be used on the departure date specified in the travel contract, or on the immediately preceding or following day, if check-in occurs at the turn of the day.

4.10. The voucher cannot be applied retroactively after a purchase has been made.

5. Cancellation Terms

5.1. The voucher does not constitute a discount on the tour price and is not factored into the calculation of cancellation fees.

5.2. Cancellation fees are governed by the applicable General Terms and Conditions of CK Join UP! Czech Republic s.r.o.

6. Final Provisions

6.1. CK Join Up! reserves the right to modify or terminate this promotion without prior notice.

6.2. In the event of a dispute, the Czech-language version of these terms and conditions shall prevail.



6.3. These terms and conditions are governed by the laws of the Czech Republic.

6.4. In the event of a dispute, the parties shall attempt to reach an amicable resolution; if this is not possible, the matter shall be decided by the court of the Czech Republic with subject-matter and territorial jurisdiction.

6.5. By participating in the promotional campaign, each participant declares that they have read and understood the content of these terms and conditions and their provisions and that they agree to them.

6.6. The terms and conditions of the promotional campaign shall become valid and effective on **June 15, 2026**.
